This position requires experience and comfort with development and production of both design and content for all types of digital media. The successful candidate will be highly creative, organized, and energetic individual, with attention to detail, who is eager to learn, enjoys handling multiple tasks, and is flexible. This position will provide park visitors with an extension of our current opportunities to learn about the natural and cultural resources at the visitor's leisure with printed and digital media.

**PRIMARY RESPONSIBILITIES**

- Write, design, and update interpretive publications, including brochures, flyers, newsletters, promotional materials for new and existing programs;
- Monitor and update agency information on social media websites;
- Create and update agency related publications such as maps, logos, brochures and marketing materials, invitations, reports, and interpretive material;
- Create storyboards, use video equipment like iPads, and use video editing software to film interviews and public events;
- Coordinate with staff from across divisions as well as vendors to complete projects;
- Continue email marketing campaign using Constant Contact;
- Assist with web design and updating of current LAMountains.com site;
- Organize and Archive digital photo collection;
- Help as needed at special events;
- Maintain agency kiosks, includes posting brochures and flyers;
- Design in other languages, Spanish fluency a plus;
- Respond to inquiries from public;
- Perform related duties as required.

**REQUIRED**

- Proficiency in Adobe Creative Suite with emphasis in Illustrator, InDesign, & Photoshop;
- Must be able to work on a PC;
- Familiarity with graphic design or related field;
- Bachelor Degree or higher preferred in related field;
- Ability to work independently and carry out assignments with little or no supervision
- Knowledge of the principles of Interpretation;
- Ability to read, write, speak, understand and communicate in English sufficiently to perform the duties of this position;

- Must pass a physical examination including a drug test;

**REQUIRED HOURS**
