- Please note that the plans provided in Addendum #1 on June 2, 2021 have been updated and the sheets below are outlined. The updates include the work in the parking area, the ADA accessible stalls have been reduced from 2 stalls to 1 stall, a wood enclosure for the pool equipment has been added, a total of (5) trees are to be removed, and for the fencing, the addition of gates furnished with code entry is for two gates instead of one. Also shown on the Site Plan are the trees to be protected in place.
